What is the purpose of this update?

What are the risks of investing?

Risk indicator for the Aggressive Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Investors in the Aggressive Fund are charged fund charges that include GST, if any. Based on the PDS dated 30 September 2025, these are expected to be:

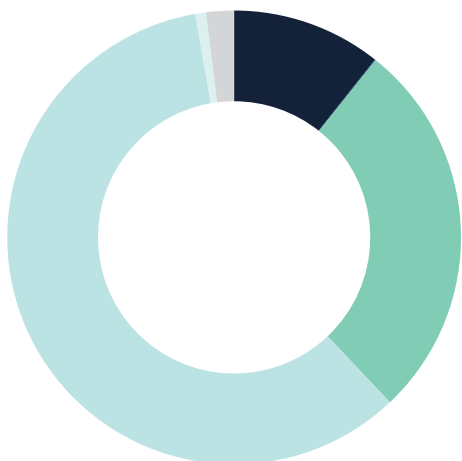
Example of how this applies to an investor

Katie had \$10,000 in the fund at 30 September 2025 and did not make any further contributions. At 31 March 2026, Katie incurred a loss after fund charges were deducted of -\$664 (that is -6.64% of her initial \$10,000). This gives Katie a total loss after tax of -\$664 for the period.

Actual investment mix

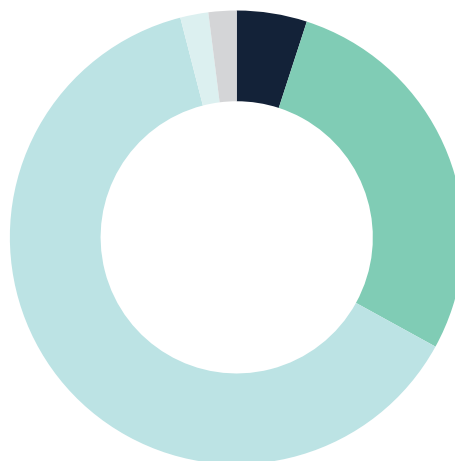
This shows the types of assets that the fund invests in.

Notes

1. Market index returns as well as the fund's actual returns have been used to fill in the risk indicator, as this fund has not been in operation for five years. Market index returns have been used from 1 April 2021 to 30 September 2025. As a result of those returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
2. An estimate has been used to calculate other management and administration charges based on a combination of forecast expenses expected to be charged to the fund and historic expenses charged to the underlying funds into which the fund invests.
