
Description of this Fund

This investment option aims to provide a balance between stability of returns and growing your investment over the long term by investing in a mix of income and growth assets, and is automatically rebalanced each year to the target fund mix of 45% Conservative Fund and 55% Growth Fund.

What are the risks of investing?

Risk indicator for the Balanced Strategy:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?



Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2025.

What fees are investors charged?

Investors in the Balanced Strategy are charged fund charges that include GST. In the year to 31 March 2024 these were:

Example of how this applies to an investor


Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$265 (that is 2.65% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$265 for the year.

Actual investment mix


This shows the types of assets that the fund invests in.
