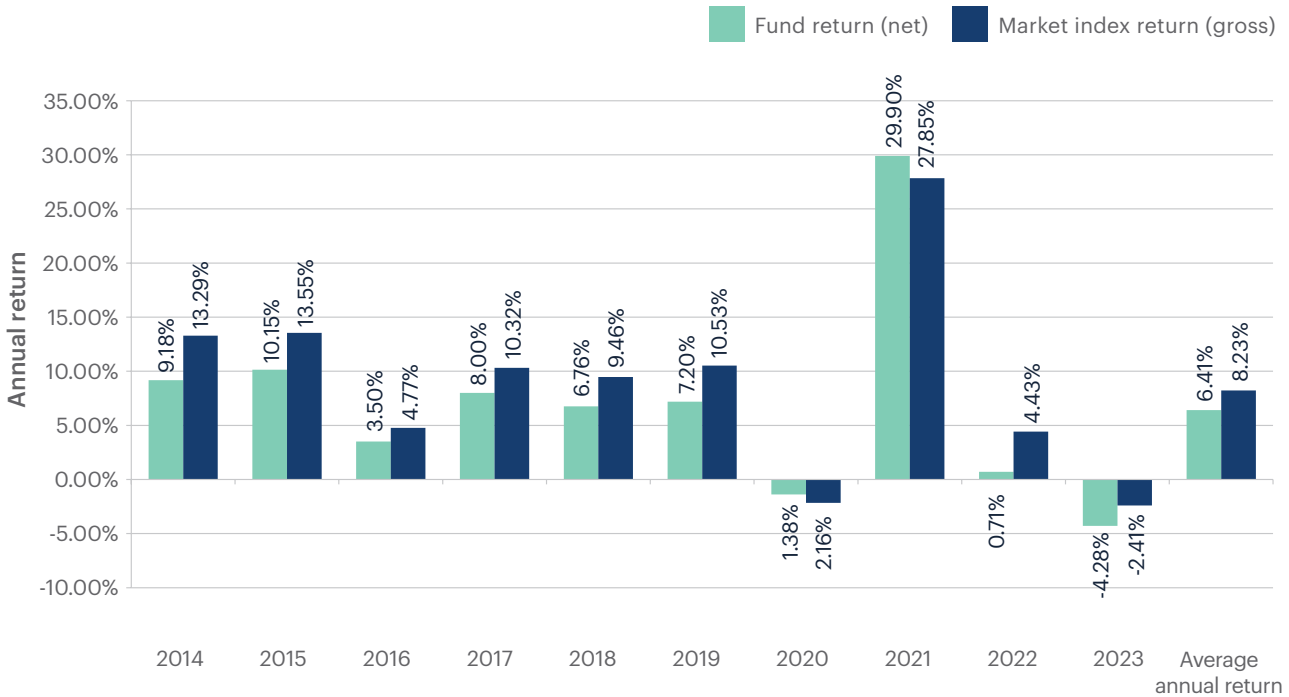


Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 September 2023.

Important: This does not tell you how the fund will perform in the future.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower. The market index return reflects no deduction for charges and tax.

What fees are investors charged?

Investors in the FuturePlan Growth Investment Fund are charged fund charges. In the year to 30 September 2023 these were:

Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$793 (that is 7.93% of her initial \$10,000). Sarah also paid \$36 in other charges. This gives Sarah a total return after tax of \$757 for the year.

Small differences in fees and charges can have a big impact on your investment over the long term.

This shows the types of assets that the fund invests in.

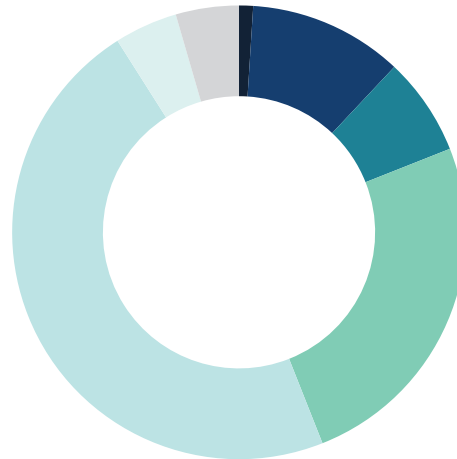
