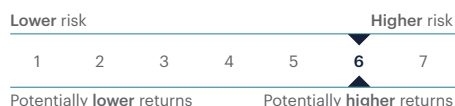
Description of this Fund

What are the risks of investing?

Risk indicator for the International Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

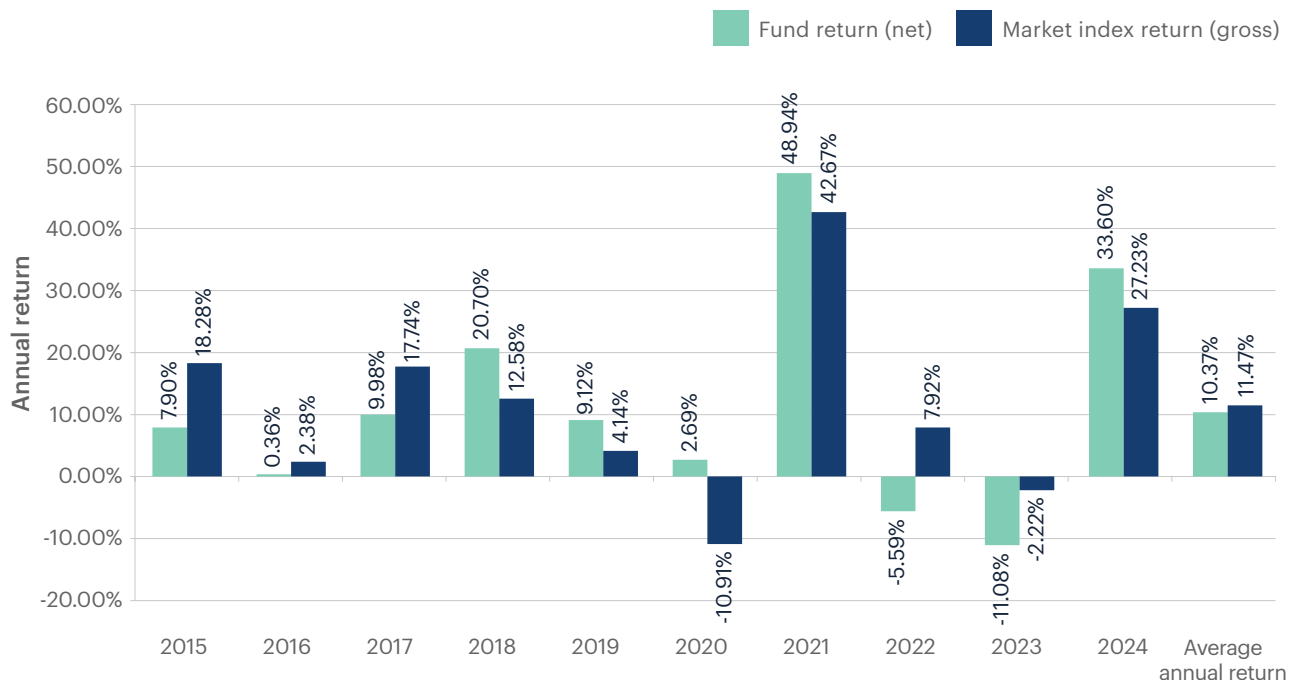

How has the fund performed?

What fees are investors charged?

Investors in the International Growth Fund are charged fund charges that include GST. In the year to 31 March 2024 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.



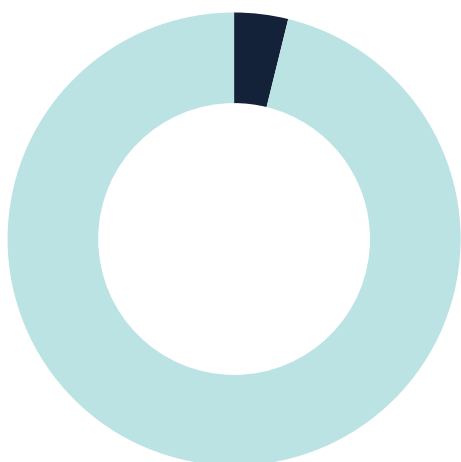
Example of how this applies to an investor

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$1,853 (that is 18.53% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$1,853 for the year.

Actual investment mix

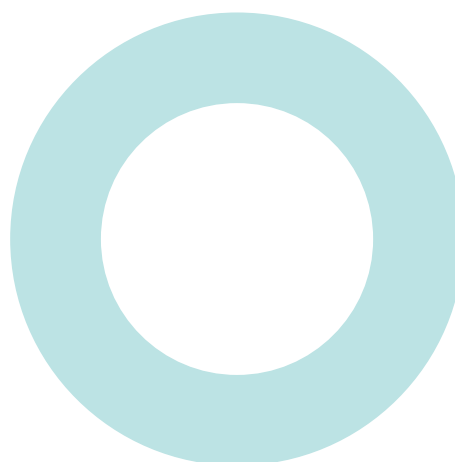
This shows the types of assets that the fund invests in.

Currency hedging

The benchmark currency hedge ratio for International equities is 50% hedged into NZD. At quarter end the fund was 50.1% hedged into NZD.
