What is the purpose of this update?

This document tells you how the Default Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to provide a balance between stability of returns and growing your investment over the long term by investing in a mix of income and growth assets. An enhanced passive investment style may be used at times.

What are the risks of investing?

Risk indicator for the Default Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

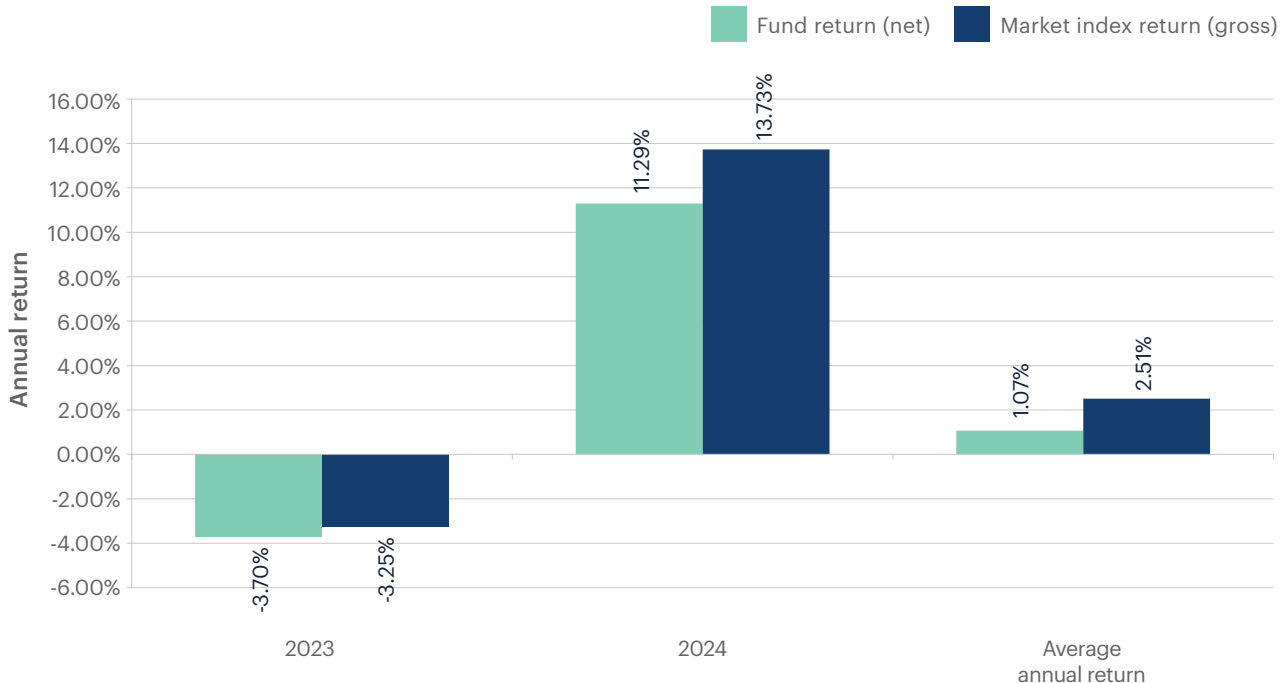

How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2024.

What fees are investors charged?

Investors in the Default Fund are charged fund charges. In the year to 31 March 2024 these were:

Example of how this applies to an investor

Alice had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Alice received a return after fund charges were deducted of \$664 (that is 6.64% of her initial \$10,000). This gives Alice a total return after tax of \$664 for the year.

An annual fund charge of 0.37% applies to Default Fund investments – unless your Default Fund balance is \$1,500 or less, in which case no annual fund charge applies.

Investors are not currently charged individual action fees (contribution, withdrawal, establishment, switching or transfer fees), but Fisher Funds may charge these or other fees in the future. Investors may also be charged buy/sell spreads for each contribution/withdrawal. See the Fisher Funds KiwiSaver Plan PDS for more information about buy/sell spreads.

Small differences in fees and charges can have a big impact on your investment over the long term.

GST is not included in any of the fees stated and will be added where required.
