What is the purpose of this update?

This document tells you how GlidePath Age 40 has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

GlidePath Age 40 is a representation of the GlidePath life cycle. This investment option invests 32% in the Aggressive Fund and 68% in the Growth Fund.

What are the risks of investing?

Risk indicator for GlidePath Age 40:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Investors in GlidePath Age 40 are charged fund charges. Based on the PDS dated 26 March 2025, these are expected to be:

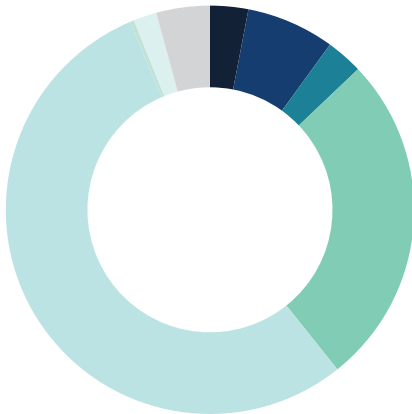
Example of how this applies to an investor³

Alice had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Alice received a return after fund charges were deducted of \$701 (that is 7.01% of her initial \$10,000). This gives Alice a total return after tax of \$701 for the year.

Actual investment mix

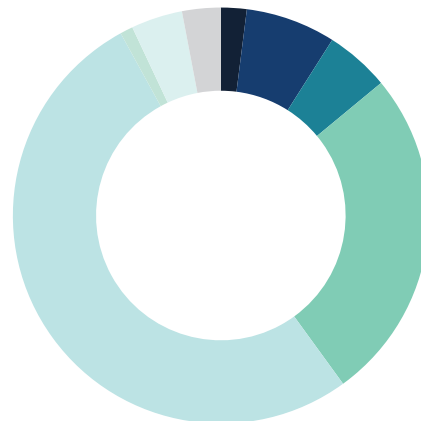

Notes

1. The GlidePath Age 40 risk indicator has been calculated using the return of the funds referenced for the age group, and its target investment mix.

3. As GlidePath Age 40 started on 26 March 2025, an annual return for the year ended 31 March 2025 is not available. For the purposes of the investor example, the return is the actual return of the market index for the period 1 April 2024 to 31 March 2025 with no deductions for charges and tax.
