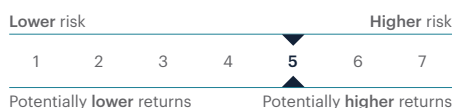
Description of this Fund

What are the risks of investing?

Risk indicator for GlidePath Age 25:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

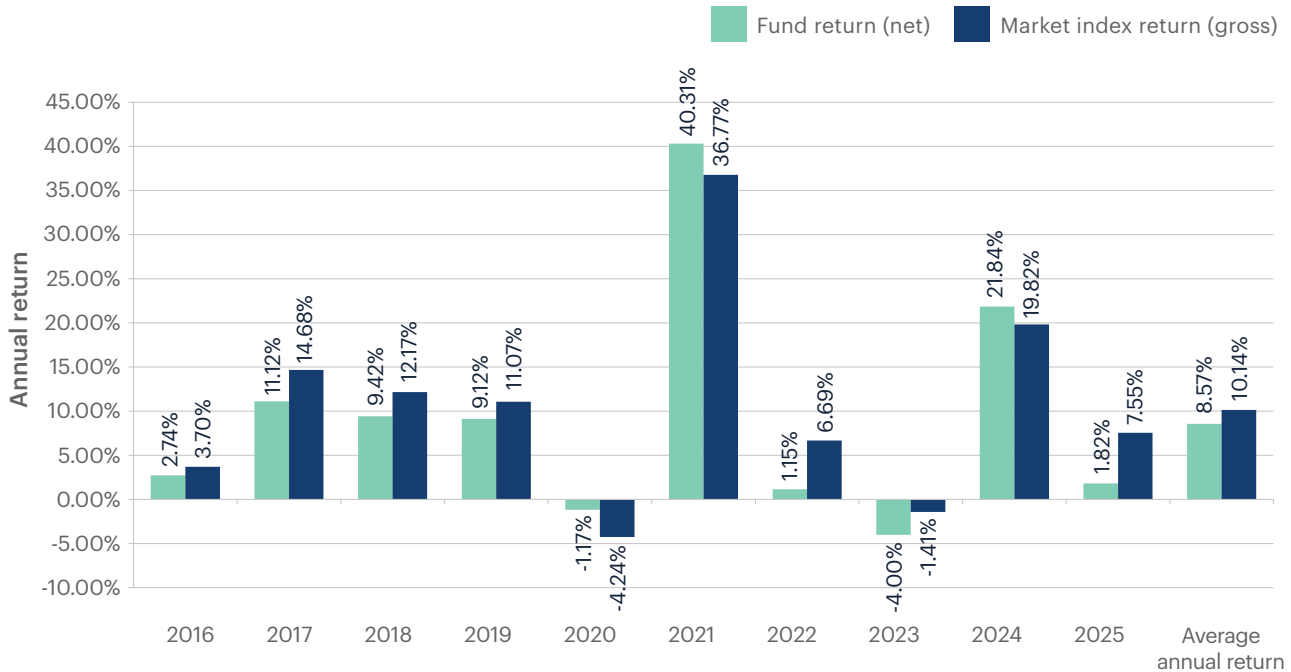

How has the fund performed?

What fees are investors charged?

Investors in GlidePath Age 25 are charged fund charges. In the year to 31 March 2024 these were:

There is no extra charge for GlidePath. The annual fund charges for the underlying fund(s) apply.

Small differences in fees and charges can have a big impact on your investment over the long term.



Example of how this applies to an investor

Jen had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jen received a return after fund charges were deducted of \$182 (that is 1.82% of her initial \$10,000). This gives Jen a total return after tax of \$182 for the year.
