What is the purpose of this update?

This document tells you how GlidePath Age 55 has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

GlidePath age 55 is a representation of the GlidePath life cycle. This investment option invests 11% in the Growth Fund and 89% in the Balanced Fund.

What are the risks of investing?

Risk indicator for GlidePath Age 55:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

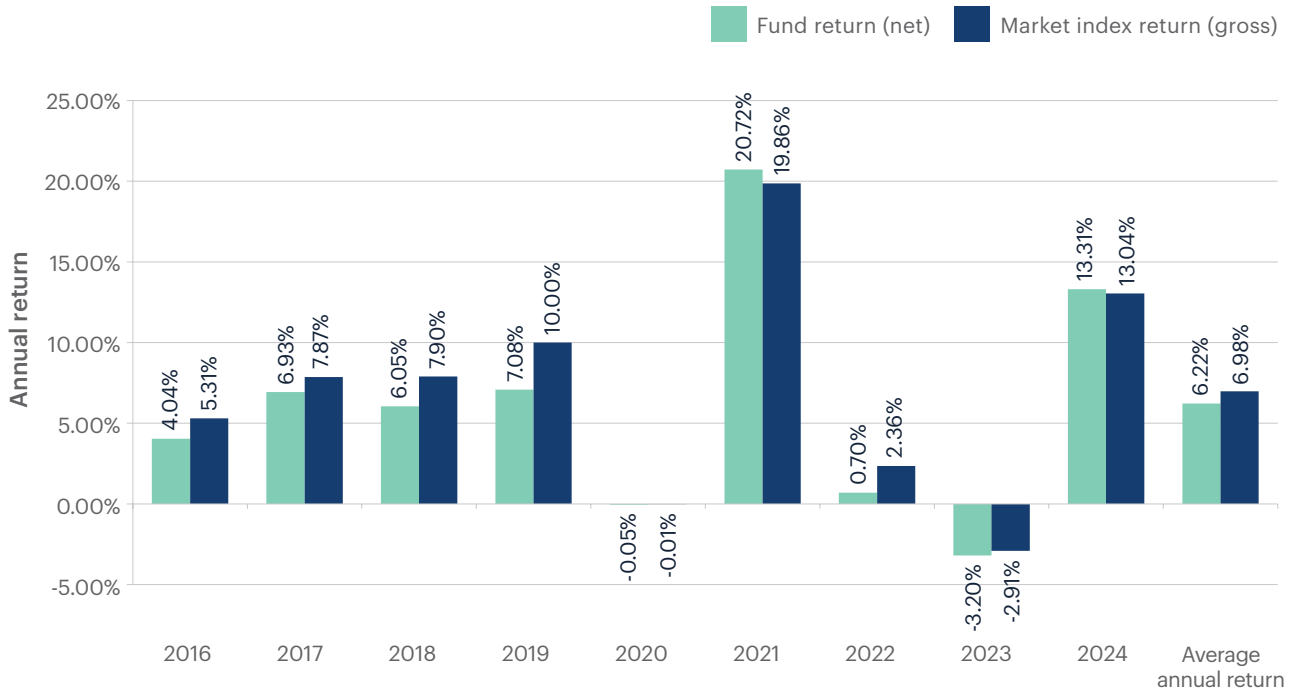

How has the fund performed?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2024.

What fees are investors charged?

Investors in GlidePath Age 55 are charged fund charges. In the year to 31 March 2023 these were:

There is no extra charge for GlidePath. The annual fund charges for the underlying fund(s) apply.

Small differences in fees and charges can have a big impact on your investment over the long term.



Example of how this applies to an investor

Jen had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jen received a return after fund charges were deducted of \$1,331 (that is 13.31% of her initial \$10,000). This gives Jen a total return after tax of \$1,331 for the year.

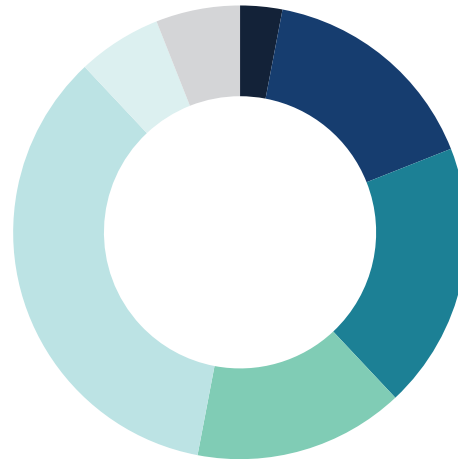
